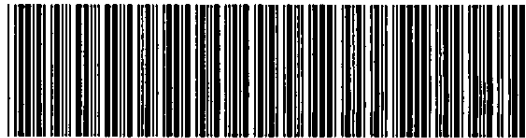



Membership Certificates shall be issued in Units of ownership. The total number of units of ownership to be issued by **PERFORMINGBIZ, LLC** shall be **100** units.


ARTICLE VI - Amendment:
