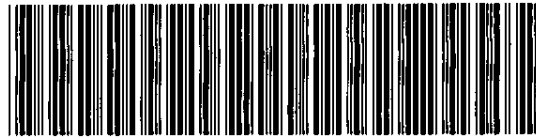

FIRST: The name of the Limited Liability Company is:

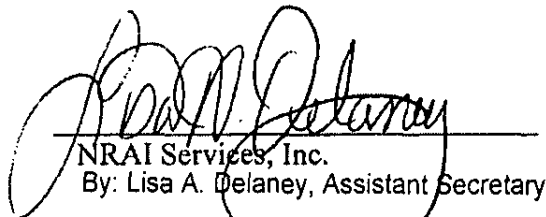

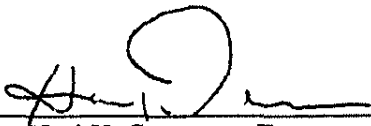
SEVENTH: The membership interests of the Members are evidenced by Certificates of Membership.
