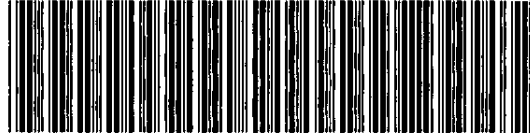

ARTICLES OF ORGANIZATION
OF

The undersigned hereby form and establish a Limited Liability Company pursuant to Chapter 605, Florida Statutes, as follows:

ARTICLE I

The name of this Limited Liability Company is DAVE PARKER COACHING, LLC.


