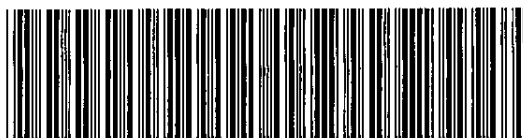


ARTICLE VI
