**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby organizes a limited liability company under the provisions of the Florida Revised Limited Liability Company Act (the "Act"), and pursuant to the following Articles of Organization:

**ARTICLE 1**

**Name**

ANY MEMBER OF THE COMPANY OR ITS ASSIGNEE SHALL BE BOUND BY THE TERMS AND CONDITIONS OF THE COMPANY'S OPERATING AGREEMENT. THE COMPANY WILL FURNISH TO ANY MEMBER OR ASSIGNEE, UPON REQUEST AND WITHOUT CHARGE, A FULL STATEMENT OF THE RESTRICTIONS AND A COPY OF THE COMPANY'S OPERATING AGREEMENT.

The Company shall indemnify its members and officers to the fullest extent authorized by law.
