**ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME & ADDRESS**

The name of this limited liability company is RDPD VI, LLC (the "Company") and its principal office address is 8200 Lov Lane, Zephyrhills, Florida 33541, and its mailing address is P.O. Box 566, Zephyrhills, Florida 33539.

**ARTICLE II
EFFECTIVE DATE**

INITIAL REGISTERED OFFICE AND AGENT**

OPERATING AGREEMENT

IN WITNESS WHEREOF, the undersigned authorized representative of the initial members has executed these Articles of Organization this 10th day of December, 2015.


