ARTICLES OF ORGANIZATION OF HERITAGE PLANTATION HOLDINGS, LLC

Pursuant to the requirements set forth in Chapter 605 of the Florida Revised Limited Liability Company Act, the undersigned hereby submits the following Articles of Organization of Heritage Plantation Holdings, LLC for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I - NAME

The name of the limited liability company shall be Heritage Plantation Holdings, LLC (hereinafter referred to as the "Company").
