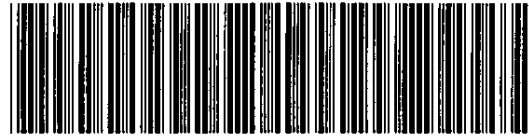



1. The Articles of Organization for Riverview Associates, LLC ("Company"), were filed on December 8, 2015. The Document Number associated with this Company is L15000206952.

2. The Amendment is submitted pursuant to Section 605.0202, Florida Statutes, to amend the name of this limited liability company. Effective the filing of this amendment, the new name of the Company is as follows:

RIVERVIEW INVESTMENTS, LLC

3. Company was advised by the Department of State, on November 19, 2015 (Ref. Number W15000076058 and Letter No. 915A00024497), that the name Riverview Investments, LLC, was not available. Company subsequently filed Articles of Organization for Riverview Associates, LLC.

4. The November 19, 2015 letter stated in relevant part that Riverview Investments, LLC, had been administratively dissolved on September 25, 2015, and that names of administratively dissolved entities were not available for a period of one year from the date of administrative dissolution unless the dissolved entity provides the Department of State with an affidavit or letter.

4. In a letter, signed and dated December 28, 2015 ("Letter"), the Manager / Registered Agent of Riverview Investments, LLC, informed the undersigned and the Florida Department of State that it "releases and forever waives all rights to the name RIVERVIEW INVESTMENTS, LLC...." A copy of the Letter is attached as Exhibit A.


