### ARTICLE V – Limitations on Manager Authority

Except by the unanimous written agreement of the Primary Members, neither a Director nor any Officer shall have the authority to enter into any agreement, contract or commitment on behalf of the Company which would obligate any Member to contribute additional capital, to guarantee a loan or to increase a Member's personal liability either to the Company or to a third party.

Except by the affirmative vote of a majority of a quorum of the Primary Members, or as otherwise required by § 6.3.2 of the Company's Operating Agreement, neither a Director nor any Officer shall have the authority to: (1) Materially alter the business of the Company, deviate from any approved business plan of the Company as set forth in this Agreement, or perform any action which would make it impossible to carry on the business of the Company; (2) Perform any action that is contrary to this Agreement; (3) Place title to any Company asset or property in the name of a nominee or sell, lease, pledge, hypothecate, or grant a security interest in any Company asset or property, except in the ordinary course of business; (4) Commingle Company funds with the funds of any other Person or Entity; (5) Confess a judgment against the Company; (6) Admit any Person as a Member, except as otherwise provided in the Company's Operating Agreement; or (7) Except as may be effected by

action pursuant to Section 17.3 of the Company's Operating Agreement, attempt to dissolve the Company.
