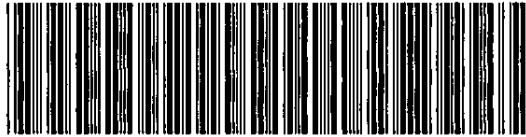




ARTICE VII - EFFECTIVE DATE OF EXISTENCE
