The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **METROPOLIA TENNIS CLUB LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2950 Deer Creek Country Club Boulevard, Deerfield, Florida 33442 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE


ARTICLE 5 - PURPOSES AND POWERS

ARTICLE 7 - ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
