

**ARTICLES OF ORGANIZATION
OF
DESTINATION DANCE, LLC**

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with FLORIDA REVISED LIMITED LIABILITY COMPANY ACT (the *Act*).

SECTION 2 NAME

The name of the limited liability company is Destination Dance, LLC, a Florida limited liability company (*Company*).

SECTION 3 EFFECTIVE DATE

The Company's effective date shall be January 1, 2016.

SECTION 4 DURATION

The Company will perpetually exist from the filing date of these Articles of Organization with the Department of State of the State of Florida, unless dissolved according to law.

SECTION 5 COMPANY'S PURPOSE

The Company's purpose is to provide dance instruction and to engage in all activities necessary or incidental to that purpose, and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

SECTION 6 COMPANY'S PRINCIPAL OFFICE AND LOCATION OF RECORDS

The street address of the principal office in the United States where the Company maintains its records is 1942 W CR 419, Suite 1040, Oviedo, Florida 32766.

SECTION 7 REGISTERED AGENT AND REGISTERED OFFICE

The Company's initial Registered Agent is MARGARET "PEGGY" R. HOYT, and the Company's initial registered office is located at 254 Plaza Drive, Oviedo, Florida 32765.

SECTION 8 ORGANIZER'S NAME AND ADDRESS

The Organizer's name is SHEILA M. SMITH, a natural person whose address is 3965 Danelion Cove, Oviedo, Florida 32766.

SECTION 9 ADDITIONAL MEMBERS

The Company has the right to admit additional Members to the Company under the terms and conditions of the Company's Operating Agreement. Any Member who is later admitted as a Member of the Company will have all of the rights and obligations of an original Member under the Operating Agreement. Any transferee of a Member's Membership Interest in the Company must be treated as an Assignee until that transferee is admitted as an Additional or Substitute Member, if ever, under the Operating Agreement.

SECTION 10 BUSINESS CONTINUATION

If a Member's membership in the Company is terminated by an event, the remaining Members of the Company have the right to continue the Company's business under the terms of the Operating Agreement. A terminating event may include the Member's death, disability, retirement, resignation, withdrawal, expulsion, or bankruptcy. If the remaining Members fail to continue the Company's business according to the terms of the Operating Agreement, the Company must be dissolved and liquidated under the Act and the Operating Agreement.

SECTION 11 OPERATING AGREEMENT AND AUTHORITY

To the extent not expressly required by and provided for in the Act, the manner in which the Company conducts its business and affairs, the duties and authority of its Members, and the rights and obligations of its Members must be set forth in the Operating Agreement adopted by the initial Members of the Company. This Operating Agreement may be amended from time to time according to its provisions.

SECTION 12 MANAGEMENT

The Company's Members will manage the Company's business. The Members have exclusive authority to act for the Company in all matters. The authorities and duties of the Members are set forth in the Operating Agreement.


SECTION 13 INDEMNIFICATION AND LIABILITY

As determined by the Members of the Company, the Company may indemnify and advance expenses to a Member, employee, or agent of the Company in connection with any proceeding. To the extent permitted by applicable laws and statutes, the Act, and the Company's Operating Agreement.

SECTION 14 TRANSFERABILITY OF INTEREST

Interest in the Company is nontransferable except as specifically set forth in the Company's Operating Agreement.




