1. Name. The name of this limited liability company is **SHERPA WEALTH PLANNING, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida. The written consent of the owner entity of the name "Sherpa Wealth Partners, LLC" is attached hereto as Exhibit A in the event the name is not deemed to be distinguishable under Section 605.0112, Florida Statutes, authorizing the filing entity to use such name.
