**ARTICLES OF ORGANIZATION  
OF  
BROWN'S HARBOR SERVICE, LLC**

The undersigned, Brown & Brown Holding Company, a Florida corporation authorized to contract, hereby presents these Articles of Organization as the Articles of Organization of Brown's Harbor Service, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Brown's Harbor Service, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company's initial principal office is 1700 Osceola Boulevard, Pensacola, Florida 32503. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be December 31, 2015. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

**ARTICLE VI - MANAGEMENT**

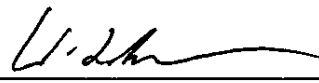
