### ARTICLES OF ORGANIZATION

OF

## NFBP, LLC

The undersigned person, acting hereby as Organizer for the purpose of forming a limited in liability company under the Florida Statutes, Chapter 605, hereby executes the following Articles of Organization:

- I NAME. The name of the limited liability company shall be: NFBP, LLC ("Company").
- II ADDRESS. The address of the principal office of the Company shall be 2127 S.W. 86<sup>th</sup> Terrace, Gainesville, Florida 32607.
- III DURATION. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.
- IV REGISTERED OFFICE AND AGENT. The name of the registered agent of the Company in the State of Florida is Hal M. Brodsky, M.D. and the street address of the registered office of the Company is 2127 S.W. 86<sup>th</sup> Terrace, Gainesville, Florida 32607.
- V CAPITAL CONTRIBUTIONS. The members of the Company shall contribute to the capital of the Company in cash or property. Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.
- VI ADMISSION OF NEW MEMBERS. No additional members shall be admitted to the Company without the written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. The regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
