ARTICLES OF ORGANIZATION OF AGENCY MANAGEMENT PLANNING, LLC

- 1. <u>Name.</u> The name of this limited liability company is **AGENCY MANAGEMENT PLANNING, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
