AMENDED ARTICLES OF INCORPORATION OF ROYAL PALM DEVELOPERS, INC.

In accordance with the provisions of Florida Statutes Sections 607.1003 and 607.1006, ROYAL PALM DEVELOPERS, INC., a Florida corporation, hereby amends its Articles of Incorporation, which were dated effective on September 8, 1989 and filed on September 11, 1989, of the Corporation as follows:

- 1. The name of the corporation is ROYAL PALM DEVELOPERS, INC.
- 2. The text of the amendment is as follows:

Article III of the existing Articles of Incorporation of the Corporation, which relates to the capital stock, is hereby deleted in its entirety and the following new Article III shall be inserted in lieu thereof:

ARTICLE III CAPITAL STOCK

The capital stock authorized, the par value thereof and the class of such stock shall be as follows:

9,000	\$1.00	Class B Common Stock

Holders of Class A Common Stock shall have the same rights and preferences as the holders of the Class B Common Stock, except that the holders of the Class B Common Stock shall have no voting rights whatsoever.

The Board of Directors shall be authorized to issue additional shares of Class A and Class B Common Stock at a par value of one dollar (\$1.00) as from time to time may be necessary and appropriate. Such increase of the number of authorized shares will require the affirmative vote of the holders of a majority of the voting shares of the company.

All powers, rights, qualifications, limitations or restrictions on capital stock not expressly provided for in the certificate of incorporation may be adopted by resolution by the Board of Directors.

3. The Amendment was unanimously adopted by the Director and Shareholder of the Corporation on November 2, 2009.
