

THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapters 605 and 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

ARTICLE I — NAME

The name of the limited liability company is NANCY D. MILLER, PLLC, (the "Company").

ARTICLE II — ADDRESS

No Member of the Company may sell or transfer his stock in the Company, except to another individual or an organization eligible to become a Member of the Company.
