ARTICLES OF ORGANIZATION **OF CAMPOSOFI LLC**

THE STATE OF THE S The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is CAMPOSOFI LLC (the "Company").
