**ARTICLES OF ORGANIZATION FOR FLORIDA
LIMITED LIABILITY COMPANY**

ARTICLE 1 - NAME

The name of the Limited Liability Company is SLIC INVESTMENTS GROUP, LLC.

ARTICLE 2 - PRINCIPAL OFFICE

ARTICLE 3 - PURPOSE

ARTICLE 4 - TRANSFERABILITY OF MEMBERSHIP INTERESTS


