**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
HANDS ON! STUDIOS, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **HANDS ON! STUDIOS, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 605.0202:

1. Name of Company. The name of the Company is **HANDS ON! STUDIOS, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State with an effective date of January 6, 2016 (the "Articles") and they were assigned document number L16000002045.
3. Amendment to Articles of Organization. Paragraph 1 of the Company's Articles is hereby amended by deleting the current text of Paragraph 1 in its entirety and substituting the following in lieu thereof:

"1. Name. The name of this limited liability company is **HANDS ON! STUDIO, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida. The written consent of the owner entity of the name "HANDS ON! INC." is attached hereto as Exhibit A in the event the name is not deemed to be distinguishable under Section 605.0112, Florida Statutes, authorizing the filing entity to use such name."
