**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
HANDS ON! STUDIO, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **HANDS ON! STUDIO, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 605.0202:

1. Name of Company. The name of the Company is **HANDS ON! STUDIO, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State with an effective date of January 6, 2016, as previously amended on January 7, 2016 (the "Articles") and they were assigned document number L16000002045.

3. Amendments to Articles of Organization.

a. Paragraph 2 of the Company's Articles is hereby amended by deleting the current text of Paragraph 2 in its entirety and substituting the following in lieu thereof:

"2. Place of Principal Office. The mailing and street address of the Company's principal office is 6230 3rd St. S., St. Petersburg, Florida 33705."

b. Paragraph 4 of the Company's Articles is hereby amended by deleting the current text of Paragraph 4 in its entirety and substituting the following in lieu thereof:

"4. Management of the Company. The management of the Company shall be vested in the managers of the Company. The name and address of the initial managers of the Company are as follows:
