**ARTICLES OF ORGANIZATION
OF
BRIGHT WING, LLC**

The undersigned, William Cody Patton, a natural person competent to contract and a member of Bright Wing, LLC, hereby presents these Articles of Organization as the Articles of Organization of Bright Wing, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Bright Wing, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the Company's initial principal office is 1911 E. DeSoto Street, Pensacola, Florida 32501. The Company's principal office and mailing address may hereafter be at such other place or places as its member or members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The initial registered office of the Company is 1911 E. DeSoto Street, Pensacola, Florida 32501, and the name of the registered agent at that address is William Cody Patton.

ARTICLE VI - MANAGEMENT

The Company shall be managed by a manager or managers in accordance with the terms of the Operating Agreement for the Company.
