ARTICLES OF ORGANIZATION OF PROPERTY UPKEEP PARTNERS, LLC

The undersigned, Gordon Tarver, a natural person competent to contract and authorized representative of Property Upkeep Partners, LLC, hereby presents these Articles of Organization as the Articles of Organization of Property Upkeep Partners, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME
