**ARTICLES OF ORGANIZATION
OF
SC HILLCREST LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is SC HILLCREST LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 176 N.E. 43rd Street, Miami, Florida 33137.

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company designates 176 N.E. 43rd Street, Miami, Florida 33137 as the street address of the initial registered office of the Company and names Jenny Nardone as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV. DURATION AND CONTINUATION

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


ARTICLE VIII. ADDITIONAL MEMBERS


