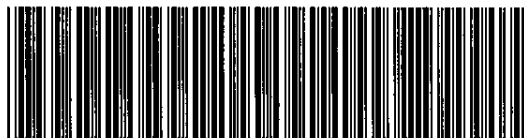

The effective date of these Articles of Organization shall be January 1, 2016.


ARTICLE VI
