**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF  
GRIDIRON GRILL-OFF, LLC**

The undersigned, as the sole member of **GRIDIRON GRILL-OFF, LLC**, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat. (the "Act"), states as follows:

1. The current name of the Company is Gridiron Grill-Off, LLC.
2. The date of the filing of the original Articles of Organization of the Company pursuant to the Act was January 6, 2016.
3. The original Articles of Organization of the Company are amended by deleting Article VII in its entirety and inserting the following in its place and stead:

**"ARTICLE VII – Initial Registered Agent and Office:**

The initial registered agent for the Company shall be Bob Baker, and the street address of the Company's initial registered office is 1900 Summit Tower Boulevard, Suite 260, Orlando, Florida 32810."

4. This amendment to the Articles of Organization of the Company was approved by the sole member of the Company.
