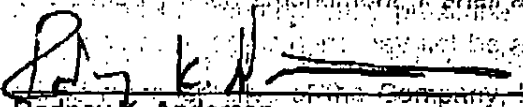
ARTICLE VI AMENDMENT TO ARTICLES

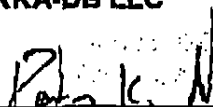
