ARTICLES OF ORGANIZATION

OF

SAT-DB LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **SAT-DB LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 1601 E. 34th Street, Pensacola, Florida 32503, and its mailing address is 1601 E. 34th Street, Pensacola, Florida 32503, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III
MANAGEMENT**

to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

ARTICLE V OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the member unless vested in the manager of the Company by any amendments of the Articles of Organization. An Operating Agreement adopted by the member or by the manager may be repealed or altered; new operating agreement may be adopted by the member, and the member may prescribe in any operating agreement made by him that such operating agreement may not be altered, amended or repealed by the manager.

ARTICLE VI AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by the sole member of the Company. In the event a new member is added by such amendment, it shall also be signed by the member to be added.

The undersigned, being the authorized representative of the Company, hereby acknowledges that, in accordance with Section 605.0203(1)(b), Florida Statutes, the execution of these Articles of Organization constitutes an affirmation under the penalties of perjury that the facts stated herein are true. (I am aware that any false information submitted in a document to the Department of State constitutes a third degree felony as provided for in Section 817.155, F.S.)
