AMENDED AND RESTATED

ARTICLES OF ORGANIZATION

OF

N & ME, LLC

(a Florida Limited Liability Company)

These Amended and Restated Articles of Organization of N & ME, LLC are hereby submitted by N & ME, LLC, pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, for the purpose of amending and restating the Articles of Organization of the limited liability company, which were originally filed on January 4, 2016 with an effective date of January 1, 2016. Therefore, N & ME, LLC hereby adopts the following amended and restated Articles of Organization:

ARTICLE I NAME AND ADDRESS

The name of the Limited Liability Company shall be Overalls, LLC ("Overalls"). The street and mailing address of the principal office of Overalls is 125 East 7th Street, Jacksonville, Florida 32206.

ARTICLE II REGISTERED OFFICE AND AGENT

The street and mailing address of the registered office of Overalls is 125 East 7th Street, Jacksonville, Florida 32206, and the name of the initial registered agent at that address is Nathan Ballentine.

ARTICLE III PURPOSE, VALUES & INTENT

Overall's primary purpose is to grow and support others to grow groceries for self and neighbor. Though profit serves Overalls like oxygen sustains the body - an essential, life-giving force that provides ongoing opportunity to create, iterate, grow, and replicate - it is not Overalls' reason for being.

There are, of course, infinite ways to grow and support others to grow groceries for self and neighbor. In pursuit of doing so in the best ways possible, as Overalls innovates, it will balance, like a four-sided seesaw: crop craft excellence, customer experience, cash flow, and community benefit: Crops, Customers, Cash & Community for short.

Overalls' intention is to provide access to fresh, healthy and unpoisoned agricultural abundance for ever more families.

ARTICLE IV ESSENCE OF OVERALLS

The Essence of Overalls is this:

Grow, Sayor, Share.

Overalls is rooted strongly, within our families and amidst our cultures, in the lives & stories of food growers and hard-working agriculturalists who have exhibited persistence and dedication in the face of heat & cold, drought & flood, sickness & exhaustion, dirt & dust, weeds & pests, booms & busts, barriers & bigotry, long days & short days, economics & politics.
