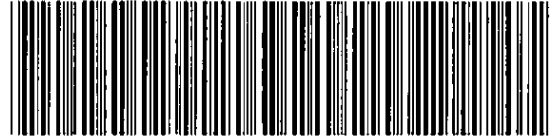

**SECOND:** Amendments adopted:


The Articles of Amendment filed on November 8, 2017 and September 17, 2018 are amended to remove Item D in its entirety.
