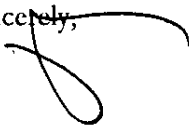

**ARTICLES OF ORGANIZATION
FOR
ENTOGENOMICS, LLC**

1. ARTICLES OF ORGANIZATION (PURSUANT TO CHAPTER 605, Fla. Stats.).

**ARTICLE I
NAME**

The name of the Limited Liability Company is as follows:

ENTOGENOMICS, LLC.

**ARTICLE II
ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company are as follows:

2940 3rd Street SW, Vero Beach, Florida 32968.

**ARTICLE III
DURATION**

The period of duration for the Limited Liability Company shall be perpetual.

**ARTICLE IV
MANAGEMENT**

The Limited Liability Company is to be managed by the sole member, and the name and address of the sole member and manager are as follows:

**ARTICLE V

Further restrictions on the admission of new members are set forth in a later executed Operating Agreement between the members.

ARTICLE VI
MEMBERS RIGHTS TO CONTINUE BUSINESS

The remaining members of the Limited Liability Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.

ARTICLE VII
PURPOSE OF FORMATION

This Limited Liability Company has been formed by the sole member for the purpose of developing and marketing molecular-based diagnostic test kits, which are designed to distinguish between insecticide-resistant and insecticide-susceptible insect pest populations in a vegetable field or greenhouse and which in turn will enable a grower to choose an effective insecticide to control the subject pest and for any other legal purposes to which the member may elect from time to time to put the said Limited Liability Company.

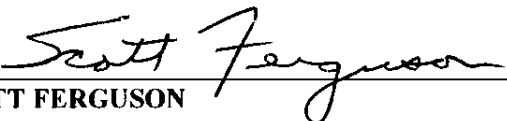
ARTICLE VIII

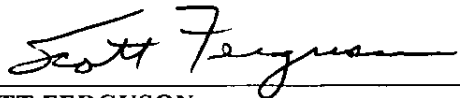
