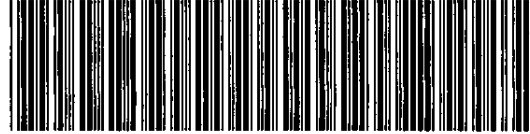

2. The "Other Business Entity" is a **Florida for-profit corporation**, first organized, formed and incorporated under the laws of **Florida** on **September 12, 2013**.


3. The name of the Florida Limited Liability Company as set forth in the attached Articles of Organization is **Jeter Publishing, LLC**.

5. The plan of conversion has been approved in accordance with all applicable statutes.




