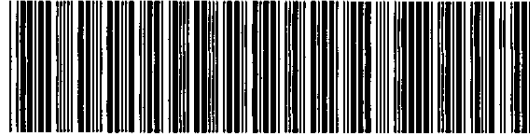


ARTICLE II. ADDRESS


