The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is 2720 Broadway Center Boulevard, Brandon, Florida 33510 and the name of the initial registered agent is Jeff Dotson. The Company may change its registered office or its registered agent or both by filling with the Department of State of the State of Florida a statement complying with Section 605.113, Florida Statutes.
