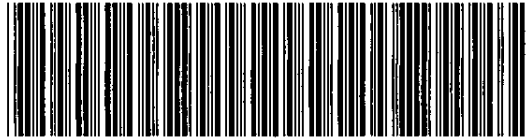

Articles of Organization of Stonehill 1049, LLC

Article One Introduction and Preliminary Statements

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with Revised Florida Limited Liability Company Act, Ch. 605, Florida Statutes (the *Act*).

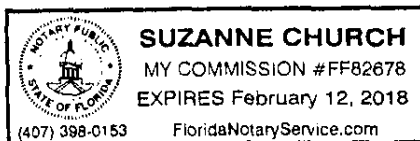
