ARTICLES OF ORGANIZATION 3001 MLK CAFÉS, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida

ARTICLE I Name

The name of the limited liability company shall be 3001 MLK Cafés, LLC.

ARTICLE II Address and Place of Business

ARTICLE III Period of Duration
