**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

The Articles of Organization of **514 NFS Café, LLC**, a Florida limited liability company (the "Company"), were filed on January 29, 2016 and assigned Florida document number L16000018870.

Pursuant to Section 605.0202, Florida Statutes, the Company adopts the following Articles of Amendment to its Articles of Organization:

**ARTICLE I  
Amendment**
