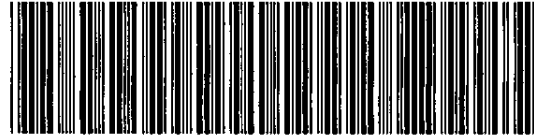

**ARTICLE I. NAME**

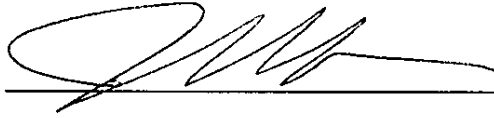
**ARTICLE IV. RENDITION OF PROFESSIONAL SERVICES**

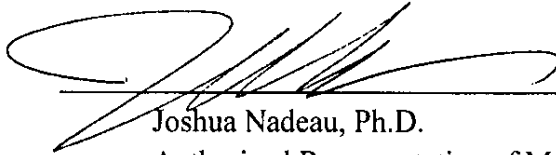
