To whom it may concern,

Last week we received notification from your office that the LLC name we applied for was declined. The application was not filed due to the name, SIMS FUNDING, not being available since it is not distinguishable from the name of an existing entity, SIM FUNDING. I contacted your office and was told that it was declined for being a plural form.

We believe SIMS is distinguishable from SIM. We would be utilizing our last name, Sims. Additionally, SIM isn't a word, therefore adding a S to the end does not make it plural. For example, if a company was named 'LEN Company' (in which LEN isn't a word) and you add an S, it would become 'LENS Company' which has a different meaning and is not plural.

We have reviewed Florida Statute 605.0112 and would like for you to reconsider approving our application for SIMS FUNDING.
