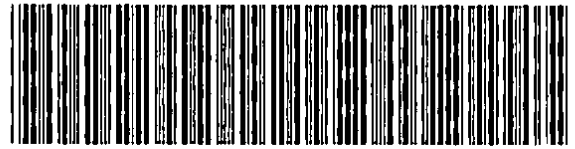

Article 8 - Termination of Existence is replaced with the terms set forth in the Amended Operating Agreement:

"The Company will be dissolved on the hapening of any of the following events: Sale, transfer, or other

disoposition of all or substantially all of the property of the company; the agreement of all of the Members;

By operation of law; or The death, incoptence, expulsion, or bankruptcy of a Member, or the occurrence of any

event that terminates the continued membership of a Member in the Company, unless there are then remaining at

least the minimum number of Members required by law and all of the remaining Members, within 120 days after

the date of the event, elect to continue the business of the Company.

Article 9 - Management is replaced with the pertinent terms set forth in the Amended Operating Agreement:

The Members, within the authority granted by the Act and the terms of this Agreement shall have the complete

power and authority to manage and operate the Company and make all decisions affecting its business and affairs:

Except as otherwise provided in this Agreement, all decisions and documents relating to the management and

operation of the Company shall be made and excuted by a Majority in Interest of the Members; Third parties

dealing with the Company shall be entitled to rely conclusively upon the power and authority of a Majority in

Interest of the Members to manage and operate the business and affairs of the Company; Whenever in this

Agreement reference is made to the decision, consent, approval, judgment, or action of the Members, unless

otherwise expressly provided in this Agreement, such shall mean a majority of the Members.
