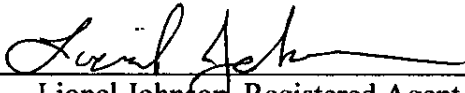

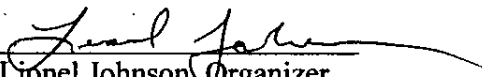
The purpose for which the company is organized is to conduct any and all lawful business for which Limited Liability Companies can be organized pursuant to Florida Statutes.
