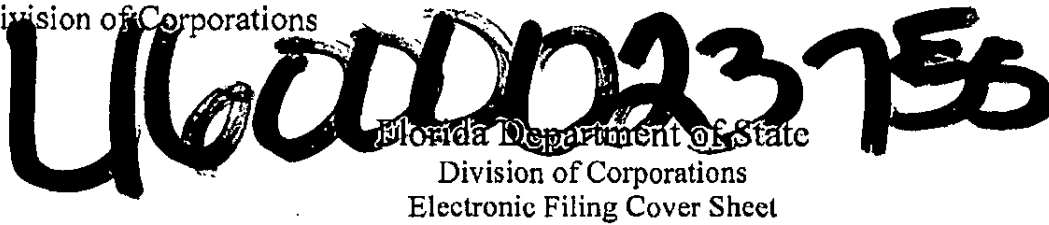

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
MARKET STREET EAST LAKE RE, LLC**

The Articles of Organization of Market Street East Lake RE, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on February 3, 2016. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

**ARTICLE I - NAME**

The name of the Company is Market Street East Lake RE, LLC.

**ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE III - REGISTERED OFFICE AND AGENT**
