## AMENDMENT TO ARTICLES OF ORGANIZATION OF TR DANBURG BOCA MEZZ, LLC, a Florida Limited Liability Company

This Amendment to Articles of Organization ("Amendment") of TR DANBURG BOCA MEZZ, LLC, a Florida limited liability company ("Company") is made effective as of Month 31, 2016, executed by TR DANBURG BOCA INVESTMENTS LLC, a Florida limited partnership ("Sole Member") and J. KENNETH TATE ("Prior Manager").

## RECITALS

- A. The Company was formed pursuant to Articles of Organization filed with the Secretary of State of the State of Florida filed on February 4, 2016 ("Articles").
  - B. The Articles of the Company have been adopted by the Sole Member.

NOW, THEREFORE, for and in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company hereby agreed as follows:

1. The Articles are hereby amended to add Article VI as follows:

## "ARTICLE VI

MANAGEMENT. The business of TR Danburg Boca Mezz, LLC shall be member managed by its Member. The Member shall be TR Danburg Boca Investments LLC having a mailing address of: 1175 Northeast 125<sup>th</sup> Street, Suite 102, North Miami, Florida 33161; provided, that the Company may determine, from time to time, to change its Member, and the Company reserves the right to update such information through its annual report filings, amendments to the Company's operating agreement, or as otherwise provided by applicable law."

2. In all other respects the Articles as amended by this Amendment, remain in full force and effect. To the extent of any inconsistency between the terms of the Articles and this Amendment, then the terms of this Amendment shall control to the extent of such inconsistency.
