**ARTICLES OF ORGANIZATION  
OF  
SACKHEIM FAMILY, LLC**

The undersigned, William E. Sackheim and Lara Sackheim, husband and wife, as tenants by the entirety, who are natural persons competent to contract and the sole member of Sackheim Family, LLC, file these Articles of Organization of Sackheim Family, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Sackheim Family, LLC, which is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company is 4627 North Davis Highway, Building B, Pensacola, FL 32503. The Company's principal office may hereafter be at such other place or places as its member or members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

The registered office of the Company is 4627 North Davis Highway, Building B, Pensacola, FL 32503, and the name of the registered agent at that address is William E. Sackheim.

**ARTICLE VI - MANAGEMENT**

The Company shall be managed by a manager or managers in accordance with the terms of the Operating Agreement of the Company. The names and addresses of the initial managers

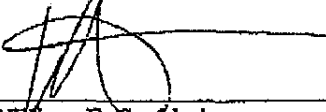

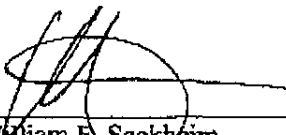
