
ARTICLE VIII DURATION

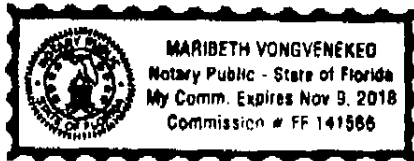
