
ARTICLE VI

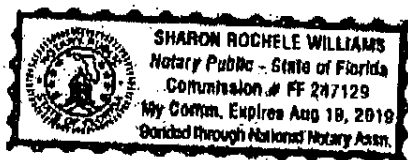


