AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

SHREE MANGAL, LLC

THESE AMENDED AND RESTATED ARTICLES OF ORGANIZATION (the "Amended & Restated Articles") of SHREE MANGAL, LLC, a Florida limited liability company (the "Company"), are submitted in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act") for purposes of amending and restating the Articles of Organization of the Company in their entirety. From and after the date of filing hereof, the Amended & Restated Articles of the Company shall be as set forth in paragraph SECOND below.

FIRST: The information required by Section 605.0202 of the Act is as follows:

- (i) The present name of the limited liability company is "SHREE MANGAL, LLC."
- (ii) The date of filing of the Articles of Organization of the Company was February 11, 2016.
- (iii) These Amended & Restated Articles will take effect at the time and date on which they are accepted for filing by the Florida Department of State.
- (iv) These Amended & Restated Arucles have been duly executed and are being filed in accordance with Section 605.0202 of the Act.

SECOND: The Amended & Restated Articles of the Company are as follows:

ARTICLE I

The name of the limited liability company is "SHREE MANGAL, LLC" (the "Company")

ARTICLE II MAILING AND STREET ADDRESS

The mailing and street addresses of the principal office of the Company are as follows:

ARTICLE HI REGISTERED AGENT

ARTICLE IV MANAGEMENT

The Company shall be a manager-managed limited liability company within the meaning of the Act and shall be governed by a written operating agreement entered into between and among its members (as amended from time to time, the "Operating Agreement"). The Operating Agreement may not be amended except as expressly provided in the Operating Agreement. The number of managers ("Managers") shall be determined as provided in the Operating Agreement. The Managers shall have the powers, duties and authority set forth in the Act, subject to any express limitations contained in the Operating Agreement. The Managers shall be elected, removed and replaced from time to time in accordance with the Operating Agreement. The names of the sole initial Managers of the Company are as follows:

Deepikaben M. Patel

ARTICLE V EFFECTIVE DATE

The effective date of these Amended & Restated Articles shall be the date on which they are accepted for filing by the Florida Department of State.

ARTICLE VI RESTRICTIONS ON TRANSFER; ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS

Among other things, the Operating Agreement restricts the sale, transfer, pledge, hypothecation, exchange, assignment or other disposition by any means, including but not limited to those which are voluntary, involuntary, by operation of law, by the laws of descent and distribution, or otherwise (each, a "Transfer") of the membership interests in the Company. Any such Transfer shall be void ab initia unless made in strict compliance with the terms and conditions of the Operating Agreement. In addition, no person or entity shall be admitted as a member of the Company or issued any membership interest in the Company, whether in

substitution for another member or as an additional member, except in accordance with the Operating Agreement.

ARTICLE VII AMENDMENTS

These Amended & Restated Articles may not be amended except as expressly provided in the Operating Agreement.

ARTICLE VIII APPLICABLE LAW

The Company is created pursuant to Chapter 605, Florida Statutes, and shall be governed by the laws of the State of Florida.
