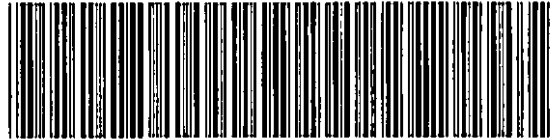


1. The name of the limited liability company is DP HOMES II, LLC.
