


**ARTICLE VII



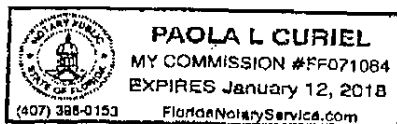
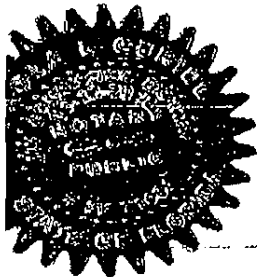
